I hereby assume all responsibilities and liabilities for my dog(s) and myself and agree to abide by all USCA guidelines and rules. I HEREBY AGREE TO INDEMNIFY, SAVE, AND HOLD HARMLESS JULIO HERNANDEZ, HER/HIS HEIRS, EXECUTORS, ADMINISTRATORS, AND ASSIGNS FROM ANY LOSS LIABILITY, DAMAGE, OR COSE, INCLUDING ATTORNEYS FEES, WHICH I MAY INCUR AS A RESULT OF INJURY, DEATH, OR PROPERTY DAMAGE, OR FROM ANY SUIT FROM SUCH PERSONAL INJURY, DEATH, AND/OR PROPERTY DAMAGE. If any part of this agreement is determined to be invalid by a Court of law, it is agreed that the balance of the agreement shall continue in full force and effect.
